Since the mid 1980's, the attorneys presently associated with Fixel & Willis law firm have comprehensively recorded their eminent domain related results while with the firm. Therefore, they believe that these results completely cover the firm's eminent domain related recoveries produced by the attorneys presently associated with Fixel & Willis from the mid 1980's through the time referenced in the track record's title.

The figures included in this list are based upon presently available documented verification in order to comply with any applicable Florida Bar regulations possibly affecting this list. The sources of over 90% of this documented verification are available public records and professionals (e.g.s. appraisers and engineers) who are not Fixel & Willis attorneys or its salaried employees.

Most offers from condemning authorities have been based on real estate appraisals of full compensation. When offers have been tendered that were not based on real estate appraisals of full compensation, the condemning authorities' appraised amounts have been used in lieu of the initial offers amounts. Where documentation of initial offers has been unavailable, the amounts of the condemning authorities' initial deposits into the court registry which allowed the condemning authorities to take the parcels have been used in lieu of initial offers. This information is available in official public records. To the extent deposit amounts are used, the deposit amounts have been frequently more, but never less, than the initial offers from the condemning authority.

Residential real estate parcels that have qualified for and received a federal relocation additive are excluded from this comprehensive list of recoveries as they are not processed the same as traditional eminent domain parcels.

Effective 1/1/2000, businesses claiming business damages must make the initial business damage offer to the condemning authority; therefore, for those post 12/31/1999 representations, \$0 is used as baseline offers from the condemning authorities for the calculation of the total additional monies secured.
