Since the mid 1980's, the attorneys associated with the Fixel Law Firm through 2020 have comprehensively recorded their eminent domain results while with the firm. Therefore, the Fixel Law Firm believes that these cumulative totals are accurate, as further explained below, and represent the firm's cumulative totals of eminent domain recoveries produced by the attorneys presently associated with the Fixel Law Firm from the mid 1980's to 1995 and yearly thereafter through the time referenced in the track record's title.

The figures that make up the cumulative totals contained in this chart are based upon verifiable and available documentation.

The figures that make up the cumulative totals listed in the third column of this chart are from three different sources which are condemning authorities' initial offers, deposits, and appraisal amounts. Most of the figures are the cumulative amounts of the initial written offers from condemning authorities which are based on the condemning authorities' real estate appraisals of full compensation. When the initial written offers from condemning authorities have been tendered that were not based on the condemning authorities' real estate appraisals of full compensation, the condemning authorities' appraised amounts have been used in lieu of the condemning authorities' initial offer amounts. When verifiable documentation of the condemning authorities' initial written offers or the condemning authorities' real estate appraisals of full compensation is not available, the amounts of the condemning authorities' initial deposits into the court registry which allowed the condemning authorities to take the parcels have been used in lieu of the condemning authorities' initial offer or appraisal amounts. To the extent deposit amounts are used, the deposit amounts have been frequently more, but never less, than the initial offers from the condemning authorities.

Residential real estate parcels that have qualified for and received a federal relocation additive are excluded from the cumulative totals contained in this chart of eminent domain recoveries.

Effective 1/1/2000, businesses claiming business damages must make the initial business damage offer to the condemning authority and the condemning authority is not required to make a counter offer. Therefore, for post 12/31/1999 representations, \$0 is used as the baseline for the calculation of the additional business damage monies secured.

No parcels of property subject to being taken or impacted by a taking are the same.
